Dawson Place Child Advocacy Center is a nonprofit organization providing safety, justice, and healing to victims of child physical and sexual abuse, assault, and neglect. We provide every service needed by child abuse victims and families, free of charge.

The Child Advocacy Center model brings all the professionals needed by child abuse victims to one place. This facilitates access to our free services, promotes interagency collaboration, and minimizes the number of times a child has to tell their story which reduces the trauma of the victim's experience.



We help families navigate the complex criminal justice and child welfare systems, all while providing healing services and giving the support needed along the way to transform hurt to hope.

All services located under one roof

All six service providers that exist to help victims of physical and sexual abuse and their families are located under one roof, making services more easily accessible.

The team of professionals partnered together with Dawson Place work to provide the best possible outcome for victims and families through care coordination.

Preventing child abuse in our community

Dawson Place breaks the cycle of child abuse by helping victims and families heal from the abuse they have experienced.

We offer parenting education classes to promote healthy families and Darkness to Light - Stewards of Children Training to help parents and community members recognize the signs of child abuse, how to respond, and how to prevent abuse from happening.
